

6. The Concerned Bureaus are, therefore, requested to issue necessary instructions accordingly. An action taken report may be sent to Vigilance Division at the earliest.

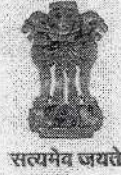
